# Vidar frá Skör

The general terms and conditions apply to all coverings through Hengstenhouderij van Nunen in 2024. The studfee is exclusive VAT, shipping costs and any documents. By registering and ordering semen the mare owner declares to have taken note of our breeding and payment conditions and agrees to these conditions.

### Insemination

Vidar is available through insemination with fresh semen. Semen shipment, EU station Denmark.

# **Covering period**

April until 14-06-2024.

We offer you the use of another stallion, free of charge if the mare has not become pregnant during this period.

# **Bookingfee**

The bookingfee is €300 exclusive 9% VAT. The bookingfee is non-refundable and must be booked before the mare is brought or semen is ordered. When the mare is scannend pregnant the bookingfee will be withdrawn from the total studfee.

#### Swab test

The mare must have a swab-test. This test can be taken at home before arrival or at Hengstenhouderij van Nunen. If the mare is unclean on the swab-test it is possible to have her treated here.

### Shippingcosts

Shipping costs of the semen are €115 exclusive 9% VAT per shipment.

# Delivery

- Mare will come to Hengstenhouderij van Nunen
- Semen will be send to the mare owner

# Mare will come to Hengstenhouderij van Nunen:

# Upon arrival

- The mare Is brought without shoes and with well-groomed hooves.
- The mare is vaccinated and the passport is delivered to Hengstenhouderij van Nunen.
- If the mare has eczema, bring the eczema blanket.
- The mare Is healthy and recently dewormed.

# **During stay**

Mares are inseminated, scanned and treated at the expense and risk of the mare owner.

Hengstenhouderij van Nunen reserves the right to call a veterinarian at our discretion at the owner's expense.

Mares with aggressive behavior or are difficult to catch are moved to a separate paddock at the owner's expense.

# Semen will be send to the mare owner:

# Semen order

Semen must be ordered before 09:00 am. <u>Order today, delivery tomorrow.</u> Semen must be ordered before the specified time, orders after this time will be processed the next day.

Veterinarian is daily before 09:00 AM at Hengstenhouderij van Nunen.  $\ensuremath{\mathsf{N}}$ 

# Delivery

Delivery is possible from Tuesday - Saturday (surcharge for Saturday delivery)

Please note: no fresh semen can be delivered on Sundays & Mondays.

# Semen order

Semen can be ordered by mail: info@hengstenhouderijvannunen.nl

The mare owner is obliged to pay the costs from the moment of the first order. No new order can be placed if payment has not been made.

The semen may not be passed on to third parties.

# Pregnancy check

Mares must be pregnancy scanned between 15 and 21 days after ovulation, and the result must be reported to Hengstenhouderij van Nunen immediately after. The remaining amount for the covering + other expenses will be invoiced when the mare is pregnant +15 days. Payment period of 14 days.

# Re-covering

In the case of stillborn (or death within 24 hours after birth) there is a right to free re-covering in 2025, in return for payment of shippingcosts and new booking fee of €300.

The re-covering may not be sold, transferred to/ or used by others and is only valid as long as the stallion is available at the EU station.

# Fresh semen

We work with fresh semen. If a stallion for a reason (illness, injury, etc.) not available is at short time during the breeding season, we offer you the use of another stallion. The bookingfee is also non-refundable in this case.

The mare owner guarantees that the mare/foal has not been in the vicinity of other horses with or symptoms of druse for the past 3 months.

Hengstenhouderij van Nunen does not accept any liability for damage, illness (druse, CEM, rhino etc.) and/or injury to people, animals, means of transport or otherwise. Horses are handled, covered & stabled at owner's risk. The mare owner is responsible for all possible costs.

Hengstenhouderij van Nunen does not accept any liability for slow or (too) late delivery of the ordered semen.

By registering the mare owner has taken note of our breeding and payment conditions and agrees to these conditions.
